

**Franklin County of Washington State Resolution to Advise AGAINST The
Use of Genetic Biologic “Vaccine” Platform Technology on Children and
Adults**

The Vaccine Adverse Event Reporting System (VAERS) is a United States Government database where reports of vaccine injury and death are entered under penalty of perjury, predominantly by health care professionals. It is the main public-facing tool used to identify safety signals, yet a CDC-funded 2011 study on VAERS found that suspected adverse events are hugely underreported.

COVID-19 shots were released in December 2020, with large numbers of reported injuries and deaths starting in 2021. See www.openvaers.com.

The total of VAERS reports in the U.S., as of December 27, 2024, shows 1,022,221 adverse events and deaths. Among those reports:

- 19,176 people died;
- 18,686 were permanently disabled;
- 90,793 were hospitalized;
- 2,071 suffered miscarriages;
- 9,512 had heart attacks;
- 5,326 had myocarditis/pericarditis.

As of December 27, 2024, VAERS shows that 24,203 Washington State residents had adverse reactions. Reports show that:

- 238 state residents died;
- 458 had life threatening adverse reactions;
- 621 were permanently disabled;
- 236 had life altering myocarditis;
- 78 suffered miscarriages.

WHEREAS:

- Hulscher et al; review stated, “More than 81,000 physicians, scientists, researchers, and concerned citizens, 240 elected government officials, 17 professional public health and physician organizations, 2 State Republican Parties, 17 Republican Party County Committees, and 6 scientific studies from across the world have called for the market withdrawal of COVID-19 vaccines.”

- COVID mRNA vaccines do not act like traditional vaccines, and are more like gene therapy products that cause human cells to generate proteins theorized to cause a specific immune response. Other COVID vaccines (using adenovirus as a vector) inject artificial spike protein and an adjuvant theorized to cause a specific immune response. Both methods involve exposing humans to spike protein, a known toxin.
- The number of COVID-19 gene therapy-associated deaths and injuries reported by US citizens far exceeds all deaths and injuries from other vaccines according to the VAERS CDC data.
- Washington State residents have no meaningful recourse to be compensated for COVID-19 gene therapy injuries with a 97% denial rate of the Countermeasures Injury Compensation Program (CICP).
- The mRNA and adenoviral vector genetic platform technology shots should be investigated due to the high number of adverse events, including disabilities, to adults and children (including children in the womb).
- The gene therapy causes cardiovascular damage such as heart attacks, myocarditis/pericarditis in all ages.
- The gene therapy is associated with injuries such as neurological damage, autoimmune issues, clotting issues, increasing rates of miscarriage and stillbirth, and adverse effects on women's reproductive systems, including **abnormal** menstruation and **impaired** fertility.
- The material in the genetic vaccines can shed and transfect through fluids and contact, as well as through **breast** milk.
- The mRNA technology shots are contaminated with 4 to 11 times above the allowable level of such DNA from the DNA plasmids leftover from the production of the shots using *E. coli* bacteria.
- Plasmids are the workhorses of recombinant DNA technologies. The DNA plasmids readily infect *E. coli*, which is present in the human gut. Plasmids also can transfer from gut bacteria to human gut cells.
- Currently no study or publicly known mechanism exists for an “off switch” to stop the production of the toxic spike protein in the human body.
- Plasmids in the Pfizer COVID-19 vaccine contain an undisclosed presence of the mammalian SV40 promoter/enhancer sequences, which have potential cancer mechanisms.
- mRNA in the gene therapy vaccines can be “misread” by the cellular machinery to produce frameshifted proteins whose effects on the body are completely unknown but may contribute to cellular dysregulation, autoimmunity, and cancer. (Frameshifting is a genetic mutation caused by insertions or deletions of a number of nucleotides in a DNA sequence.)

THEREFORE, Franklin County of the State of Washington declares that we value the health and lives of our citizens including children. Out of an abundance of caution, we recommend:

- AGAINST any administration of the gene therapy vaccines for infectious disease indications, in any modality, in our community;
- Removing these gene therapy vaccines from the child vaccine recommendations in our county, and in the State of Washington, until:
 - Completion of a comprehensive evaluation of the pharmacology, immunology, mutagenicity, carcinogenicity, toxicology, and effect on fertility of the COVID-19 vaccines.
 - Completion of an epidemiological investigation of the health outcomes relating to the use of COVID-19 vaccines used by the residents of Washington State.
 - Completion of long-term double-blind placebo studies that are made available to the public.
 - Transparent, accurate, and complete informed consent is available for all individuals and parents.

THEREFORE, Franklin County of the State of Washington supports legislation that:

- Creates corporate liability for harm due to products that use mRNA, DNA, or any genetic technology in any product, plant, or animal;
- Provides for appropriate compensation and treatment for Washington citizens harmed by the gene therapy vaccines;
- Requires informed consent, transparency, and labeling of any product that uses genetic technology for any human, animal or agricultural use; and
- Prohibits mandates – local, state, national, or global – regarding medical procedures or interventions in any modality.

THEREFORE, Franklin County of the State of Washington requests that:

- Benton Franklin Health District (BFHD) Board conducts a thorough review, presentation and discussion of the adverse effects of the COVID-19 gene therapy vaccines (by subject matter experts) at a public meeting; and
- The BFHD board cease to provide, fund or promote gene therapy vaccines for infectious disease indications **until the above conditions are satisfied.**
