I am making my own hotel arrangements and will not be staying in the DCCC block

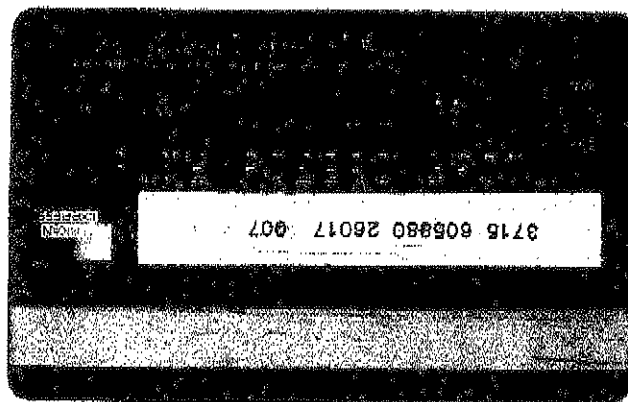
